



LEASH & BRIDLE BOARDING

BOARDING CONTRACT

This is a contract between Leash & Bridle Boarding and I, the pet owner, whose signature appears below. By signing this contract and leaving my pet with Leash & Bridle Boarding, I certify to the accuracy of all information given about said pet.

I, the owner, acknowledges that it is not possible to protect against all risks to my dog(s)/cat(s) at any time, even with the exercise of due care and attention whether at the kennel or in transport, that these risks include injury, escape, theft, disease and fire.

I, the owner, specifically represents to the kennel that my pet has not been exposed to rabies or distemper within a thirty-day period prior to boarding and that it is in good health and current with all required immunizations. Dogs: DHLPP, Rabies, and Bordetella. Cats: FVRCP and Rabies.

If my pet becomes ill or injured and it is deemed that the state of my pet's health requires professional attention, Leash & Bridle Boarding in its sole discretion, may engage the services of a veterinarian, administer medicine or a special diet, or give other requisite attention to my pet and the expenses will be paid by myself, the owner. In the case of a medical emergency, the maximum dollar amount that, I the owner, authorize to be spent on veterinary care is \$_____. If my pet were to pass while in the care of Leash & Bridle Boarding, I understand that the remains will be stored at my current Veterinarian, unless I instruct otherwise.

I, the owner, understand that, my pet(s) will be with other pets during its stay at Leash & Bridle. I understand that the kennel will not admit animals into play areas that are obviously aggressive. If, however, a pet acts out of character or unpredictably and my dog is injured, I agree to not hold Leash & Bridle or their agents or staff liable in any way for these unforeseen acts. If for any reason my pet is found to be incompatible with the group play, the kennel has the authorization to separate my pet into a private kennel for the duration of its stay.

I, the owner, release Leash & Bridle Boarding from all liability for injury, damage or loss suffered by me, my pet(s), members of my family or guests and which loss is or may have been caused directly or indirectly by any act or omission of Leash & Bridle or by any person or property in the vicinity and during the course of Leash & Bridle providing the services requested and whether resulting from negligence or any cause. I agree to indemnify Leash & Bridle Boarding and save it harmless from all claims and costs of any nature and kind in respect of any loss caused or contributed to by my dog/cat(s) including any damage to the property of Leash & Bridle Boarding and I assume the sole risk of and the responsibility for same.

Any controversy or claim arising out of or relating to this contract, or the breach therefor, or as the result of any claim controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration and judgement upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney fees.

This contract contains the entire agreement between the parties. All terms and conditions shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Leash & Bridle for this visit and all subsequent visits.
